Environmental Impact Statement

IN FEBRUARY THIS YEAR, the NSW Department of Planning and Environment issued Kingsgate Bowdens with a revised set of Secretary's Environmental Assessment Requirements (formerly DGRs now SEARs) that clearly articulate what is required in order to lodge an Environmental Impact Statement (EIS) for the project.

Kingsgate is well advanced on the preparation of the EIS, and work is continuing to focus on some of the larger elements such as groundwater and power supply options. As the EIS nears completion Kingsgate will provide an opportunity to discuss key elements of the EIS with the local community.

Environmental Update

Kingsgate is committed to striving towards best standards for environmental management and to continually improve its environmental performance.

Monitoring

Environmental monitoring has continued on site, covering most relevant aspects. Surface water quality and groundwater level monitoring continues monthly with comprehensive water quality analyses undertaken every quarter. Twenty seven surface sites and up to fifty water bores are monitored monthly. Two pump tests were conducted successfully in December 2014 that have greatly improved our understanding of the long term characteristics of the fractured rock aquifers near the proposed mine site. This information will be used in the modelling of the aquifer. Two stream gauging stations are continuously recording water level and flow rates in Hawkins Creek.

This data has reflected the dry seasons that have occurred in the past few years, with falls in water levels within most bores. A number of the surface

water measurement sites have dried up and there has been a lack of flow at the upstream gauging station and reduced flow at the lower station compared to similar times in the previous year. Air quality monitoring at eleven sites and the two weather / continuous airbourne dust concentration stations continue to operate.

Access to weather information

Access to weather information has been arranged so that the local community can also access the weather station data. Details of the website are given below to easily access the data measured in your area.

Current Situation

We are currently utilising the Bowdens property and other properties purchased over the past few years for agricultural purposes, with plans to expand our cattle herd and sheep flock into the future. During this period, the current management strategy is to improve pasture and sow small areas of forage crops to produce quality fat lambs and cattle for sale in local markets through support from local livestock agents. Along with sale of livestock, we will continue to improve infrastructure on our land, including upgrades to fencing, livestock handling and farming equipment, while supporting local business through purchase of required supplies through local vendors and employment of local community members to support our agricultural enterprise, where possible.

Kingsgate Bowdens has always strived to support the local community wherever possible, through employment of local people and supporting local businesses.
