## **Chatree Gold Mine Update**

Kingsgate Consolidated Limited ASX:KCN (“Kingsgate” or the “Company”) is pleased to advise that the remaining ten 777 trucks and additional 6030 excavator have arrived at the Chatree Gold Mine and are currently being commissioned. All core Caterpillar mining equipment is now on site which allows for further mined ore to be fed into Plant 1 and Plant 2, which are now collectively operating above their combined nameplate capacity.
